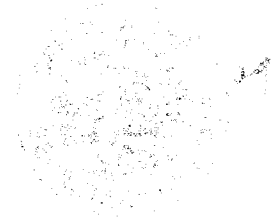

5. To plan and schedule dive trips, and to provide other opportunities for members to interact socially with an emphasis on socialization and safe, fun SCUBA diving activities.

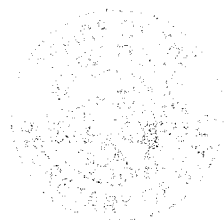
